

# Chokecherry and Sierra Madre Wind Energy Project

## Site-specific Environmental Assessment for Phase I Wind Turbine Development

The Bureau of Land Management (BLM) Rawlins Field Office is accepting scoping comments for a site-specific environmental assessment for Phase I Wind Turbine Development for the Chokecherry and Sierra Madre Wind Energy Project (CCSM). The CCSM Record of Decision determined that over 200,000 acres within the CCSM Project Area are suitable for wind energy development subject to the requirements described under the Selected Alternative, but did not identify individual turbine or infrastructure component locations. Subsequent tiered environmental assessments (EAs) are needed to analyze site-specific issues. The first analyzed is the infrastructure component EA, which was available for scoping from September 9 through November 4. The second EA will address the Phase I Wind Turbine Development. Please complete and submit this comment form at the public scoping meetings. You may also return this form by mail to the address on the reverse side. For your comments to be the most effective, the BLM suggests the following guidelines:

- Be specific. Give defined reasons, not broad statements or opinions.
- Share site-specific observations, data, or knowledge.
- Detail important environmental and community factors.
- Be timely. Comments must be received by January 14, 2014 to be considered in the environmental assessment.
